Dear Members and Alliance friends,

The first two months of the year have been some of the busiest of late in the Alliance. We began the year with a meeting alongside Barnardos, with Taoiseach Leo Varadkar and Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman. The meeting focused on the scale and scope of the newly announced Child Poverty and Wellbeing Unit which is due to be established in the Department of Taoiseach at the end of Quarter 1 this year. The Unit has the potential to be a gamechanger in our ambitious goal to end child poverty and is coming at a critical time in Ireland, with the latest data published by the CSO showing that the number of children impacted by poverty increased across the board in 2022.

As we issue this newsletter, we unfortunately mark one year on from the outbreak of war on Ukraine with the Russian aggression continuing to have an enormous impact on the number of refugees arriving to Ireland and across Europe. Our focus continues to be on safeguarding, the reception response and education. We continue to work with members and stakeholders as part of the Civil Society Ukrainian Forum as pressure on accommodation increases. If we can assist you in your work, please contact us.

In January, the UN Committee on the Rights of the Child continued their examination of Ireland's record on children's rights. Ahead of the two-day hearing, we published our alternative report, Are We There Yet, an interactive publication that highlights key issues for children and young people and details 73 recommendations to the Irish Government.

At the end of January, a State delegation travelled to Geneva to enter into a constructive dialogue with the UN Committee. I travelled over with Alliance team members and our member network to witness the proceedings. Before the hearing, a significant report published by the Mental Health Commission revealed further failings in Child and Adolescent Mental Health Services that placed a spotlight on the need for urgent improvements in the State provision of mental health care and support to our young people.

At the end of February, we published our fifteenth Report Card – the third tracking the Government's progress on their commitments for children in the Programme for Government: Our Shared Future. I would like to take this opportunity to thank you, our members, for you continued engagement with the Report Card process and support on the launch. We were delighted to see its content raised in the Dáil several times last week, including by Taoiseach Leo Varadkar.

I look forward to meeting some of you at our next in-person event in April. I hope it is the beginning of more of more in-person meetings to come together as we continue to build a national movement for children and young people.

Thank you, as always, for your continued and greatly valued support.

Fostering Children's Rights

UNCRC

In January, the Children's Rights Alliance published <u>Are We There Yet?</u>, our alternative report on Ireland's record on children's rights to coincide with Ireland's examination by the UN Committee on the Rights of the Child. The report, which followed written and thematic consultations with our members, details **73 recommendations** to the UN that highlight the need for urgent and significant Government action. As part of this report, we hear directly from young people and parents on how persistent issues pertaining to children's rights impact their lives and, in some cases, irrevocably change it.

The UN Committee examinations are our opportunity to weigh up if we are delivering for children and young people. The Children's Rights Alliance led a delegation of our members to Geneva for the two-day hearing at the end of January. Following this, the UN Committee published its own recommendations ('Concluding Observations') on how the Irish State could better uphold and protect the rights of children and young people.

Report Card

Our annual **Report Card** series remains a key resource in ensuring that Government keeps its promises to children and young people. Report Card 2023 is the third analysis under the Programme for Government: Our Shared Future, tracking the Government's commitments to children in health, housing, education, early years, poverty and equality. An independent panel of experts graded the Government's performance and this year that included two 'A' grades in online safety and an 'E' grade on youth mental health. At this year's launch we were delighted to be joined by Dr Sindy Joyce, Karen Kiernan and Ian Power. We also heard directly from young people involved in Youth Work Ireland and Foróige youth groups, on their own experience of living in Direct Provision. Children's Rights in Law, Policies and Practice

Children's Mental Health Services

Almost a year to the date of the publication of the HSE Review of South Kerry Child and Adolescent Mental Health Services (CAMHS), the Mental Health Commission published <u>an interim report</u> in January that highlighted further failings and concerning shortcomings in the provision of youth mental health services in Ireland. Building Children's Futures - Using Children's Rights to Recover from the Global Pandemic

Through consultations with groups that were disproportionately impacted by the pandemic, the 'Building Children's Futures' project, led by the Children's Rights Alliance, will examine the effect of the pandemic public health measures on services for children and young people. With our partners at the University of Galway, we have established a youth advisory committee that will include representative voices from specific groups of children disproportionately impacted during Covid-19.

These are Children and Young People

- living in poverty and experiencing educational disadvantage;
- with special educational needs;
- accessing health services;
- accessing mental health services;
- accessing disability services;
- Traveller and Roma Communities;
- refugee/asylum seeking children and young people;
- at risk of violence, abuse and neglect;
- living in emergency accommodation.

Early Years

The Children's Rights Alliance is part of a campaign co-led by <u>Eurochild</u> on Early Childhood Development. The campaign advocates for the prioritisation of early childhood development

in public policies, with a particular focus on families and children who are at greater risk of discrimination and exclusion. We are delighted to share that we have commissioned the Early Childhood Research Centre (ECRC) at Dublin City University to undertake research on the development of a public model of childcare in Ireland. Poverty and Social Exclusion

Child Poverty Unit

At the end of 2022, incoming Taoiseach Leo Varadkar announced his intention to establish a new unit in the Department of Taoiseach focused on child poverty and wellbeing. We welcomed this significant development as a gamechanger in the efforts to turn the tide of child poverty we are seeing in Ireland today. The new unit follows the successful track record of other child poverty offices in Scotland and in New Zealand. In January, the Children's Rights Alliance met with Taoiseach Leo Varadkar and Minister for Children, Equality, Disability, Integration and Youth, Roderic O'Gorman TD. At the meeting, we discussed the proposed scale of the new unit as well as the need for resourcing and adequate staffing. In February, the Alliance called for this again to emphasise the importance of supporting ambitious targets for the unit following the publication of the latest Survey on Income and Living Conditions (SILC) data from the Central Statistics Office which showed an increase across the board in child poverty. Ukraine Briefings

The Children's Rights Alliance sits on the Ukraine Civil Society Forum. In February, we held a cluster meeting on Education, Youth and Children as part of this work. Our focus continues to be on issues including: safeguarding and child protection, language acquisition and integration in the school setting. Following commissioned research into the educational needs of children arriving from Ukraine, we are liaising with Tusla and the Department of Education and we will be arranging a member briefing on this topic over the next quarter. Holiday Hunger Food Provision Scheme

As a means to address this 'holiday hunger', we ran a food provision scheme over Christmas and January this year, supporting many of our member organisations, including schools, to provide food vouchers and hampers to children and their families. There was an overwhelmingresponse to this limited scheme and we would like to thank our valued donors

who worked with us to secure vital funding to support thousands of children and young people over the winter months.
