This involves monitoring, developing and advocating for the rights of children in Ireland’s laws, policies and services at national, European and international level.• The team is responsible for producing a wide range of reports and submissions including the flagship publication, the annual <i>Report Card</i> series, as well as engaging in high-level advocacy, and providing support to members.

Key Duties:	<p>The work of the Fellow will focus on children’s rights and child law and may undertake the following duties:</p> <ul style="list-style-type: none"> • Legal analysis of relevant legislative proposals that may impact on children and recommending of areas to improve the rights of children. Track their progress through the Houses of the Oireachtas and analyse amendments made. Engage in advocacy activities. • Contribute to the Children’s Rights Alliance international work in relation to the UN Committee on the Rights of the Child and the Council of Europe and advocate on the international jurisprudence that flows from these bodies. • Participate in our advocacy work in support of our positions. • Contribute to research on the Children’s Rights Alliance <i>Report Card</i>, which monitors and grades Government performance in relation to children’s rights. This is the Children’s Rights Alliance flagship publication and is highly influential. • Provide legal information and support to members of the public and second tier advice givers through our <i>Access to Justice</i> Helpline and Clinics where the opportunity arises. • Deliver training as part of our <i>Know Your Rights</i> guide to provide basic information to children and young people on their legal rights and entitlements and support the review of the guide. • Prepare article for publication in the Bar Review. • Deliver a lecture/webinar for Law Library members.
